We organize a project called Portland Rising that puts thousands of workers and supporters in action together. We educated people around many campaigns, including security guards organizing, teachers bargaining a contract and community groups fighting budget cuts.**

**Our health care work is focused on winning access to affordable health care for everyone. Our health care committee is working on educating the community and collecting photo petitions in support of universal health care. The committee continues to take a lead role around educating and organizing people in the Portland area around the idea that health care is a human right.**

**Our immigrant rights committee played a key role in building a coalition to stop the collaboration of immigration enforcement and local law enforcement, which creates deep fear in immigrant communities and reluctance to rely on the police for routine public safety problems.
