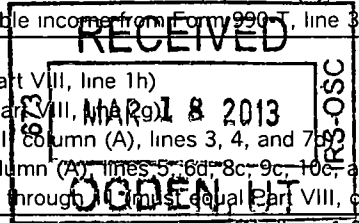

These include Group Counselors, Therapists and Assistants. The volunteer factor is incalculable. The dedication and devotion from individuals is astonishing. The web of both regular and irregular volunteers offers Angels at Risk substantial and steadfast support financially and programmatically. This is immeasurable. Also, legal services, classrooms, security, office space and general help.

These would have had to have been purchased if not donated. We valued these services at between \$227,000 to \$240,600 during 2012.

- 1) Parent-Teen support groups (free to Westside community/schools/informal juvenile court).
- 2) Classroom speakers and counselors for campus support groups/Lunchtime Educational Meeting and After School Educational Meeting.
- 3) School based assemblies for parents. School based assemblies for teens.
- 4) We facilitate in-service workshops (teachers/PTSA/police/community resources/conferences).
- 5) Generating public awareness via web site, events, media, education and 12-step meetings, stories for school newspapers/web sites.
- 6) We provide support with crisis management in collaboration with community drug and alcohol resources.

In addition to providing education and support, Angels at Risk also oversees all documentation required for court-referred clients (most of whom come from Santa Monica Juvenile Court).
