To sponsor participation in college preparatory programs and to provide university scholarships for young Liberian adults who were academically disadvantaged by the 14 year civil war in Liberia

**PART III:**

**ORGANIZATIONS' PRIMARY PROGRAMS:**

**SCHOLARSHIP PROGRAM**

Ongoing review and refinement of university scholarship program goals and structure, equal opportunity policies, application, and terms. A total of 26 students received academic scholarships in 2012, including 2 high school students and 24 students attending one of five carefully selected Liberian partner universities. Of these university students, RYHF celebrated 9 graduates in 2012 in Architecture (1), Agriculture (2), Nursing (3), and Pre-medical sciences (3). The remaining 17 students continue to maintain the required high academic standards for scholarship, pursuing careers identified as in critically short supply in post-war Liberia. To maximize student safety and success, support services are made available as needed to scholarship recipients, RYHF student union members, and RYHF alumni. These services including tutoring, individual counseling for post-war trauma, aid with emergency life circumstances, and issues of reintegration into Liberian Society. Through the RYHF scholarship program, individuals and their families benefit and RYHF is contributing to the nation's re-building goals.

**RAISE YOUR HAND FOUNDATION STUDENT UNION (RYHF-SU), LIBERIA:**

The vision for RYHF-SU is to maximize individual potential, support student success on college campuses and to give back to the community through volunteerism. RYHF-SU was founded in 2009 at Cuttington University (CU) in Suakoko, Liberia, and was officially recognized as a campus organization by administration on February 26, 2010. Since its inception, the CU chapter has hosted campus-wide leadership seminars, college fairs for regional high school students, peer tutoring programs, and campus beautification projects. In 2012 the members of RYHF-SU at CU anticipated a large reduction in membership due its majority of graduates, and developed a transitional governing body, initiated a membership drive, launched fundraising efforts, and began planning for sponsored projects in the new year. Expansion of RYHF-SU to other partner campuses and establishment of an RYHF Alumni Association are also ideas under development.

### **CALVARY REVIVAL COMMUNITY SCHOOL (FREETOWN, VIRGINIA, LIBERIA)**

In 2012 RYHF continued its community service partnership with Calvary Revival Community School, also referenced as "Virginia School". This school meets a great need in a rural Liberian community that had absorbed 88 orphaned and homeless children into their families when Liberia abruptly placed a moratorium on international adoptions. These families were already desperately poor and most were unable to afford the cost of education any of their children, much less these new family members. Virginia School provided a pre-kindergarten through grade 2 opportunity for the children of these families to receive instruction in very basic mathematics and reading, taught in a church building by unpaid, minimally trained, but highly motivated staff. Despite these challenges, the children had shown progress through their studies and it was the goal of this community to see their school become officially recognized, accredited (and offered material support) by the Liberian government. RYHF worked alongside Virginia School to meet the following government requirements: (1) Build separate boy/girl bathrooms and (2) Complete a well for safe, clean water on the school site. By early 2012 both were complete and RYHF provided the fees to pay for final government review. On July 4, 2012, Virginia School met all requirements, received its attestation and became formally recognized as a Liberian grade school. At the end of 2012 RYHF helped with funds to construct an annex and the school expanded its teaching to include grade 3. RYHF is also exploring a partnership with a local teacher certification program to provide training and support for the Virginia School Staff.

### **DANJA FISTULA CENTER AND LEPROSY HOSPITAL, NIGER REPUBLIC**

This community service partnership was launched in November 2012. One of the RYHF Advisors to the Board is serving as current director of the Danja medical facilities in Niger. In 2012 RYHF provided funds to rebuild the leaking roof of the Danja injection clinic and established a partnership with the local Lions Club to facilitate ongoing shipments of refurbished, donated eyeglasses to the Leprosy Hospital. The first 3 shipments of eyeglasses were sent in November 2012 and all of the glasses were immediately distributed to patients, with an expressed appeal for more to be sent.
