

The Marol Academy's mission is to initiate and support primary education in rural South Sudan. The first effort has been to provide teacher salaries, build classrooms, a library, latrines, and staff office, and provide school supplies and uniforms for the Marol Primary School in the village of Marol, Warrap State, The Republic of South Sudan.

Service Accomplishments

Since April 2008, the Marol Academy's efforts have been to provide teacher salaries, build classrooms, a library, latrines, and staff office, and provide school supplies and uniforms for the Marol Primary School in the village of Marol, Warrap State, The Republic of South Sudan. The village has 200 permanent residents, no electrification and no roads in or out. Because of the school, there is now a borehole and hand pump, made possible by the UN, CESVI (an Italian engineering firm) and The Marol Academy, giving access to clean water.

In December 2011, 620 girls and boys completed their school year at the Marol Primary School, with 40 of them completing Grade 8, a successful culmination of their primary education. Some of the 18 teachers tutored the 40 pupils beyond December—the end of the school year – in preparation to sit for the national secondary school entrance exams. The reported results from the Ministry of Education showed the Marol pupils produced the highest scores in Warrap State.

Accomplishments in 2011 through the donation of USD 56,575 to the school included the following:

Teacher salaries - \$12,000 + \$10,392 set aside for 2012  
Completion of classrooms (plastering, painting, installation of doors and windows, and purchase of timber for desks and chairs) - \$6,000  
On-going construction (materials for kitchen and dining facility and labor costs) - \$24,000  
Cost of shipping a 1997 Dodge Ram Truck to South Sudan for use by the school - \$3,575  
Bank fees - \$608
