how to provide neonatal resuscitation. Local Midwives received continuing education & a Birthing Center is currently under construction.

Women and children were treated during 14 weeks of short term medical trips. 200 Children received worm prevention treatment every 6

months. 400 children received fluoride treatments to prevent tooth decay.

PART III #29 EDUCATION - Computer Labs set up in local school. Continue after-school enrichment program. 400 books in Spanish sent.

American teacher working full time in local Guatemalan school teaching English, Math and computer skills.

American teachers provided continuing education for local teachers. 20 Students were financially sponsored so they could attend school.
