ACCREDITATION: By the end of 2012, GFAS had accredited/verified a total of 132 facilities. GFAS accredited our first European sanctuary and added 2 verified sanctuaries in Africa in 2012.

GFAS also awarded a total of \$45,302 in compliance grants (grants given to help sanctuaries achieve accreditation/verification).

ANIMAL RESCUES/TRANSPORT PLACEMENTS: In 2012, GFAS assisted in the placement of more than 500 animals in need. Also in 2012, GFAS and Exec. Dir. Patty Finch were awarded the prestigious 64th Annual Honor Award by US Secretary Vilsack, Secretary of Agriculture, USDA, for the prominent role GFAS played in the rescue and placement of the 323 animals from the failed Wild Animal Orphanage in Texas.

STANDARDS, KEY PRESENTATIONS AND OTHER OUTREACH: In 2012, GFAS began a review of its standards and reformatting. GFAS was selected as co-presenter with the ASCPA in the ASCPA/Schaefer Family Workshops for equine rescues. GFAS hosted numerous webinars on such topics as volunteer management, building operating reserves, grant writing & fundraising. GFAS presented at other workshops, served on state committees & exhibited at such groups as Taking Action for Animals.
