The Organization's services include primary and preventative care, in-house labs, digital x-ray, vaccinations, diabetes education, access to medications, treatment of acute and chronic illnesses, vaccinations and on-site medical specialties including cardiology, mental health counseling, endocrinology, ophthalmology, vascular, and more. The Organization has enrolled approximately 2,000 patients, had roughly 7,500 patient visits in 2012, and offers 18 medical specialties on-site.
