Part III: Both Hands projects provide an outlet for volunteers to fulfill James 1:27 in a practical way. In 2012, 109 Both Hands projects took place across the U.S., serving 110 widows, helping 117 children become adopted, and raising funds for orphanages around the world. Each project starts with a team of volunteers who work on a widow's house. Most of the time we do light repair, painting, cleaning and landscaping. The team of volunteers also sends letters to their contacts requesting sponsorship for the day while they work on the widow's house. The money raised through sponsorship goes 100% toward adoption funding and orphan care. In 2012, \$1,130,000 that was raised through projects went directly to adoption funding and orphan care through Lifesong for Orphans, a not-for-profit which collaborated with Both Hands.

Part VI: The Form 990 is reviewed by the full board of directors at its monthly meeting in February. Both Hands Foundation did not have (1) a written conflict of interest policy, (2) a written whistleblower policy, or (3) a written document retention and destruction policy in 2012 but is currently in the process of preparing these. The process for determining compensation for the organization's Executive Director included review and approval by the independent board members, after researching industry averages and a survey from the Center for Non-Profit management.
