The Friends of Coconino County Parks (FCCP) is a non-profit organization with the mission of supporting Coconino County Parks and Recreation Department's efforts in the areas of land conservation, park development, volunteerism and recreational activities FCCP accomplishes this through efforts that include 1) Generating funding to benefit County Parks, 2) Facilitating arrangements with volunteers and other organizations for cooperative work efforts and 3) Advocating for parks and open space

Our annual fundraiser, the Flagstaff Wine & Food Festival, is now a recognized summertime event in Northern Arizona In 2012 it attracted over seven hundred and fifty attendees and received rave reviews by vendors and sponsors There were over 100 supporters and volunteers who participated in the event planning and worked the event We successfully operated the Beer/Wine Garden and the Homebrew Competition at the 2012 Coconino County Fair, providing friendly and helpful customer service and a great selection of drinks Other Fair vendors, our beer suppliers, and patrons commented positively about the operations All in all, we raised just over \$28,000 during the four-day event We have two legacy funds The late Bruce Mason, a founding Board member, left \$575 to be used for the improvement of the County Fair The family of Michael Lunn established a fund to be used for the improvement of trails This fund has a current balance of \$1,500 with annual donations being made by various family members on the anniversary of his death We served as a fiscal sponsor for the Town of Fredonia and facilitated donations for the construction of a fitness trail We awarded a \$5,000 grant to Coconino County Parks and Recreation toward the completion of the Flagstaff Loop Trail Segment 20 We completed our More Kids in the Woods program which was the result of a grant from the Arizona Game and Fish Department The program consisted of a series of six free guided hiking educational activities to explore Coconino County parks and natural areas We mobilized resources for the construction of Ponderosa ramada, a sustainable shade structure at Sawmill County Park We collaborated with Coconino Horsemens Alliance in fundraising and resource mobilization to build the Community Equestrian Arena at Fort Tuthill County Park We currently have over 110 volunteers/friends for our organization
