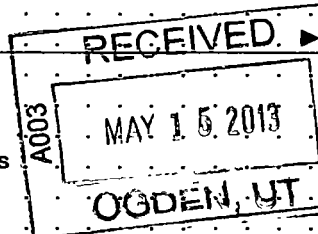

The faith-based Performing Arts Academy will provide opportunities that will enhance character, promote well-being, and inspire greatness by developing people through the Arts. The Academy desires to change lives by offering affordable, quality music education, positive theatre experiences, and an appreciation for the Arts.

The community and students will be encouraged to participate in small and large ensembles and theatrical opportunities. All teachers and staff at the Academy are to aspire to a level of excellence in teaching and performance.

The Academy will serve primarily Butler and Warren Counties and surrounding communities. No participant will be denied study at the Academy due to socio-economic conditions.

Part III – Statement of Program Service Accomplishments

Performance

In the performance side of the PAA, the following activities were successfully undertaken. Rehearsals for each production included voice and performance instruction. Participants came from approximately 13 area communities. In 2012, 10 musical theatre productions were accomplished.

Each production involved working with youth for 3 to 14 weeks. Objectives accomplished included the education of children in performance, music and dance through theatre arts. They received the opportunity to gain self-confidence, self-discipline and enrichment within their lives, experienced the value of working with others towards a common goal, and provided to the community productions which displayed “excellence” in all aspects. Success has been measured by tracking the attendance in music and theatre classes, tracking the number of returning students and the low drop-out rate. Another measure is the superior and excellent ratings the PAA students receive at the Ohio Music Education Association solo and ensemble contests.
