4CORE oversaw the weatherization of 143 low-income homes in 2012 throughout the five county region encompassing Archuleta, Dolores, La Plata, Montezuma, and San Juan Counties with grant funds administrated through the Colorado Energy Office. The administration and implementation of the Department of Energy Weatherization Assistance Program realized an estimated \$68,783 in annual utility bill savings for program recipients including 60 multi-family apartments located in Cortez, Colorado. Local utility companies also contributed funds in the form of rebates for weatherization measures for insulation and furnace and refrigerator upgrades. Approximately, 96% of the homes weatherized had unsafe health and safety issues, including gas leaks, which are now remedied. 4CORE also collaborated with local partners to offer free weatherization services and demonstrations at the Por Dia Preschool and Learning Center in Cortez. 19 volunteers and 36 attendees participated in this event.

4CORE trained and certified the following during 2012: five certifications in Radon Measurement, three certifications in Radon Mitigation, nineteen certifications in CPR and First Aid, ten certifications as Building Performance Institute Heating Analyst (Building Science Training), seven certified as Building Performance Institute Envelope Professionals (Building Science training), two certified as Lead Renovators, and two re-certified as Asbestos Inspectors.

4CORE launched the Resource Smart Business Program to advance the efficiency and sustainability of local businesses, assisting 20 businesses through a collaboration with local government and seven local businesses with funding from the Environmental Protection Agency, Climate Showcase Communities Grant. The Southwest Solar Transformation Initiative (SSTI), part of the DOE Solar Rooftop Challenge was

introduced to regional municipalities and utilities to recommend best practices in solar processes for planning, zoning, and interconnection. For the SSTI effort 4CORE was a subgrantee under Optony Solar. 4CORE also facilitated a working group to discuss compressed natural gas for regional fleets. 4CORE launched the HomeRx program pilot to save energy and improve health, safety, and comfort in non-low income homes and partnered with a local bank and a local economic development agency to pilot energy efficiency lending programs. Home Spotlight Tours of a net zero home and Energy Star 3 homes were held in 2012. 4CORE newsletter circulation increased to over 2,000 subscribers and 7,190 resource efficiency information requests were responded to. For 2012, there were 187 participants at various SBEP educational sessions.
