The Bread Basket provides a food pantry which is open to individuals and families in the community every Friday. Our food pantry is run by volunteers from several local congregations under the direction of the Program Administrator. We have dedicated volunteers who faithfully come to fill and distribute food orders. The Food Pantry is stocked through the support of our churches and local business. Bulk supplies are purchased from the Mountaineer Food Bank. Emergency food assistance is available as needed - 2,259 Families were assisted during 2012

The Gabriel Project provides needed baby clothing and items (diapers, cribs, car seats, etc) to families in need. In the Gabriel Room, a staff volunteer helps select the necessary items to nourish the child. Often our Gabriel Room receives gifts from our donors of diapers, clothes (boys/girls 0-7), clothing accessories, baby food, blankets, and stuffed animals - 142 Families were assisted during 2012
