During 2012 and through The Forsaken Children's partnership with the Onesimus Children Development Association (an Ethiopian NGO), the Onesimus Drop-In Center in Ethiopia was funded, allowing it to open its gates to countless children living on the streets and those in danger of joining them. The Forsaken Children estimates that approximately 2,000 children and adults are impacted through the drop-in center each year. Additionally, the Kota Ganate Hatchery was established to create a sustainable in-country source of revenue for the NGO and strengthen the surrounding communities. Kota Ganate has developed as a working farm, implementing proven sustainable farming practices to increase the productivity of the land. Through demonstration, training, and technical assistance, Kota Ganate has and will transfer these practices to farmers in the area. The farmers will then be able to increase the productivity and profitability of their land without having to assume the risks involved with developing new techniques.
