The Joshua Collingsworth Memorial Foundation (JCMF) experienced many accomplishments in 2012. The foundation was honored to sign Memorandums of Understandings for National Partnerships with the United States Coast Guard (March), the National Water Safety Congress (March), the USA Swimming Foundation's Make-A-Splash National Affiliate (June), and the US Army Corps of Engineers Omaha District (October). Furthermore, the JCMF developed an infant and toddler swimming program called "Float4Life" with the Salvation Army KROC Center in Omaha, NE, with plans to expand it nationwide. The foundation continued to expand the Rotary Josh the Otter Water Safety and Literacy Project with Rotary International Rotarians across the country, purchased 9,697 Josh the Otter water safety packets for children. The foundation also experienced a growth in our retail online catalog for all of the materials displayed in the catalog. The foundation created a Bilingual Spanish/English version of the "Josh the Baby Otter" Book to reach more children and families around the US and Spanish-speaking countries.
