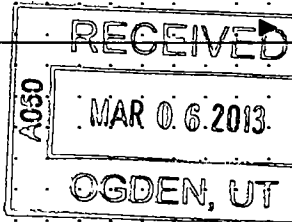

3. Article 11 of the Articles of Incorporation is hereby amended to read as follows:

The purpose for which the corporation is organized is to establish a mission-based charity in order to promote and enhance the health, education and wellbeing of children and orphans who are deeply entrenched in a continuous cycle of poverty in Ssempeya, Uganda. This will be achieved through charitable donations to build and operate a school and orphanage for these poverty stricken children and orphans.

"Kayongo's Hope is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes."
