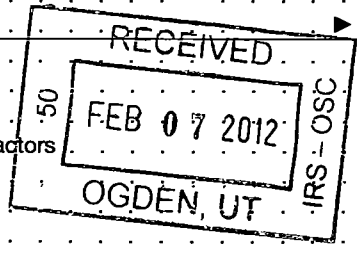



**Part III**

Copper's Dream Rescue's primary exempt purpose is to end the euthanasia of adoptable dogs in the United States. Currently our biggest program service is rescuing dogs that are scheduled for euthanasia at high kill California shelters and housing them in foster homes until permanent homes can be found. In 2011, we rescued 326 dogs and finalized 324 adoptions. In the process, we assisted hundreds of families with identifying a rescue dog that would be a good fit for them. Our second program service is to increase public awareness of the animal overpopulation problem and encourage people to join our cause. In 2011, we recruited 50 new volunteers to help with marketing our rescue dogs, staffing our adoption events, and designing flyers and brochures to educate the public. We also recruited 65 new foster families to temporarily house our rescue animals until permanent homes could be found.
