OUR AWARENESS PROGRAM EDUCATE COMMUNITIES THROUGHOUT THE COUNTRY ABOUT THE REALITIES OF SEXUAL EXPLOITATION, PROVIDE UNIVERSITY STUDENTS STUDYING HUMAN TRAFFICKING (DATA FOR THEIR RESEARCH), AND ASSIST FIRST RESPONDERS IN IDENTIFICATION OF VICTIMS. WE HAVE PARTICIPATED IN OVER 98 PUBLIC EVENTS AS GUEST SPEAKER AND EDUCATED APPROXIMATELY 6,000 INDIVIDUALS.
