Operating since 2006, the Pipeline Entrepreneurial Fellowship program has become the critical hub of the Midwest's emerging entrepreneurial ecosystem. Initially available only to entrepreneurs in Kansas, Pipeline has now expanded to support entrepreneurs throughout the greater Midwest with major hubs in Kansas City, Omaha, Wichita and Lincoln. Pipeline is unique in the nation, operating with a model developed over years of testing and innovation. Pipeline works one entrepreneur at a time, it works with small groups of entrepreneurs on the assumption that a few committed individuals can change the world. Starting with a small handful of firms, Pipeline has now developed a sizable and successful network of growing businesses. As the network grows, its transformational power also grows. The impact is clear. Pipeline entrepreneurs have seen their revenues grow by more than 22% and jobs grow more than 8% after joining the organization--at a time when most US businesses have been retrenching. In just a few short years, Pipeline has helped place 3 of the 6 Kansas-based firms on the prestigious Inc 500 list--an honor reserved for America's top entrepreneurs. Helping entrepreneurial companies grow helps regions grow too. Pipeline seeks to build world-class firms, but it also seeks to construct a world-class entrepreneurial infrastructure in the Midwest. Pipeline entrepreneurs, advisors and investors give back by investing in new businesses and coaching other entrepreneurs so that future generations can also succeed on their entrepreneurial journeys. They themselves have become essential players in the ecosystem. From 2007 through 2012, 46 companies have been led by Pipeline Members. Pipeline Member firms presently employ 771 people across Kansas and the Midwest. More than 300 of these jobs have been created after participation in Pipeline. Their average salary among Member firms is nearly \$66,000. Pipeline Member firms generated \$141 million in revenues in 2011 and have raised more than \$31 million in outside capital since 2008. Half of Member firms export and work with international partners and now do business in 47 different countries. Nearly 2/3 of participants report introducing a new innovation that emerged thanks to their involvement with Pipeline. Many of these innovations (40%) have received patents or trademark protections, but a large portion relate to new products or new management approaches.
