See Schedule O Research The Foundation's primary focus is to support the Linda Crnic Institute for Down Syndrome, the first academic home in the United States committed to research and medical care for people with Down syndrome In 2009, the Foundation launched the Be Beautiful Be Yourself Fashion Show - the single largest annual fundraiser for Down syndrome The event, which has now expanded to two locations- Denver and Washington D C , provides awareness by highlighting models who have Down syndrome and funds critical research and medical care at the Crnic Institute Such research focuses on sleep apnea, physical delays, Alzheimer's disease, congenital heart disease, and autism - diseases and conditions that a large number of people with Down syndrome have The Foundation also supports the Crnic Institute's Sie Center for Down Syndrome to provide the best multidisciplinary care for children with Down syndrome The Sie Center is working to update medical guidelines for children with Down syndrome, and will help to ensure that families, doctors and other healthcare providers have access to updated information
