Through education and access, DC Greens works to bridge the gaps in our local food system to ensure that all DC residents have a deeper connection to the sources of their food and can afford fresh, local fruits and vegetables. Our two main programs are Food Access (provides added funds for low-income patrons to shop at farmers' markets, and includes a Fruit and Vegetable Prescription Program), and School Garden Program (professional development workshops for garden-based education).

School Garden Program: Garden-based professional development workshops for public and charter school teachers. Management of a collection of public school gardens in the District of Columbia. Internship program to train college students in garden-based education while providing critical support to school garden teachers. School garden program trained 50 teachers and 25 college students in 2012. The program impacted more than 6,000 public and Charter school students in the District of Columbia.

Food Access Program - administration and funding of a program that gives additional monies to recipients of three federal food programs, the Supplemental Nutrition Assistance Program (SNAP), the Women Infants and Children Program (WIC), and the Senior Farmers' Market Nutrition Program (SFMNP) so that they may better afford fresh local fruits and vegetables, while bringing federal dollars into the local farm economy. We also run a Fruit and Vegetable Prescription Program whereby doctors prescribe fruits and vegetables to patients that are at high-risk for obesity-related chronic health problems. These patients then fill their prescriptions at five participating farmers' markets. During the 2012 pilot, 53% of patients enrolled in the program saw a decrease in their Body Mass Index Percentile (BMI) over the course of the 6-months. The hospital also saw an increase of 68% in retention rates for preventative health visits because the patients were eager to receive their prescriptions.

Farmer's Market Program: Community-based farmers' market to increase access to local foods, support local farm economy, and provide educational experiences for young market patrons. Roughly 500 patrons attended each week of the season.

\$9,748 for Farm-to-School Programs - DC Greens is the "state lead" organization for the National Farm to School Network. Through our Farm-to-School programs, DC Greens provides experiential opportunities for D.C. public and charter school students to connect with their food.

We help schools coordinate chef demos and farm field trips. DC Greens also lead workshops with teachers to train them in how to build bridges between the cafeteria and the classroom. Growing Healthy Schools Week is a key event in our farm to school programming - an annual city-wide event that provides more than 10,000 students at 63 schools with a learning experience associated with local foods.

\$5,802 for Rooting DC which is a free urban gardening educational forum that provides more than 60 hands-on agriculture workshops to over 800 residents from all wards of Washington, D.C. DC Greens took over this annual event in 2012, though Rooting DC is in its sixth year. More than 80 DC nonprofits working in food access and urban agriculture run tables in the info area making this a key meeting ground for education and collaboration.

\$19,405 in General Program support which includes but is not limited to: DC Greens' participation in commissions and collaboratives that advance our mission of food justice, access, and education in the District; collaboration and strategy sessions with other nonprofit leaders that span multiple programs; getting out general information to the public about our programs and missions as a whole; general programmatic support that is not specific to any one program but benefits all programs.

**Part VI 11b:** The Executive Director (who is also a Board Member) prepares the Form 990 with the accountant and then discusses the initial draft with the Board Treasurer. Once the draft has been reviewed and revised with the Treasurer, a copy of the Form 990 is distributed to all members of the Board.

**Part VI, 12c:** Every Board Member is provided a copy of the conflict of interest policy when they join the board. At the beginning of each fiscal year, every Board Member is provided with a listing of DC Greens' major vendors and requested to sign a statement that declares that they know of no current conflicts of interests or a statement what conflicts of interests they have.

Part VI, 15: In setting the compensation of the Executive Director, DC Greens adheres to a compensation-setting process that includes:

- 1. Review of the proposed compensation by independent members of the Board or compensation committee;
- 2. Review of published comparability data about compensation paid by similarly situated organizations of similar size; and
- 3. Deliberation and contemporaneous documentation (meeting minutes) of this information by the independent members of the Board or compensation committee.

Part VI, 19: DC Greens complies with the public inspection requirements of the Internal Revenue Code section 6104 by making publicly available upon request its Form 1023 including all related correspondence; its determination letter from the IRS; and its Forms 990 and any Form 990-T for its three most recently completed tax periods. However, as section 6104 does not require organizations exempt under section 501(c)(3) to disclose their governing documents, conflict of interest policies, or financial statements, DC Greens does not make such information available for public inspection.

Part IX, 24a: DC Greens runs farmers' market incentive programs in the District of Columbia. With funds raised from foundations, corporations, and individuals, DC Greens provides additional money for low income residents (SNAP) to be able to purchase fresh fruit and vegetables. We also run a Fruit and Vegetable Prescription Program (FVRX) that provides fresh produce to patients that are at high-risk for obesity-related chronic illnesses. Both programs are run using tokens at the market that are distributed to patrons and used to buy local foods. For low-income participants, these tokens add to benefits that recipients already receive to ensure access to fresh produce by increasing affordability of the farmers' market produce. Patrons of both programs use the tokens to pay farmers for their produce and then the farmers turn the tokens into DC Greens and DC Greens pays each farmer for the tokens redeemed. Both of these programs help to ensure that vulnerable community members can afford local, fresh produce while also properly compensating participating farmers.
