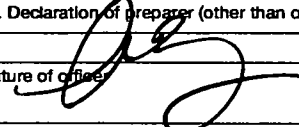
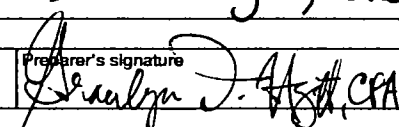

Prospekt Mira was commissioned by the UNDP Lao PDR country office project team, in conjunction with the National Agriculture and Forestry Research Institute of Lao PDR (NAFRI) to produce a baseline video/knowledge product documenting the effects of climate change, drought, and floods in the target areas of the Improving the Resilience of the Agricultural Sector in Lao PDR to Climate Change Impacts (IRAS) programme. Filming was completed in November of 2012. The video is currently in post-production, and is expected to be released in 2013.

Prospekt Mira was contacted by UNEP Grid-Arendal for video from Small Island Developing States (SIDS) that was used in a film that is looking at Arctic Biodiversity Trends - Selected Indicators of Change. The film's subject was change in the region (human induced and natural) and also the global implications of that change (i.e. changes in plants, animal movement, communities, traditional livelihoods, weather patterns, tourism, industry, erosion etc.).

Prospekt Mira's footage was used to show changes in SIDS that are related to biodiversity changes in the arctic, especially the impacts of climate change on coastal areas (including erosion and sea level rise). Our footage was selected because it shows the inter-relationship of communities and people in Tuvalu and the water.
