What is the organization's primary exempt purpose?

The organization's primary exempt purpose is to provide meaningful outdoor education experiences for youth. This is done through curriculum-based multi-day wilderness river programs that incorporate healthy risk-taking, leadership building, academic lessons, team-building exercises, and conservation education.

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.

**28** In 2012, GOALS worked with students from schools throughout Colorado, as well as from out of the state, to design and implement customized outdoor experiential learning opportunities for kids between 4th and 12th grade. The number of students we are affecting has increased from only 4 programs in 2011 with 306 days spent by program participants in wilderness river canyons to 7 programs accounting for 489 days outdoors learning in the canyon environment. The schools we provided programs for in 2012 included Rifle Middle School in Rifle, Colorado, Clear Creek Middle School and Clear Creek High School in Evergreen, Colorado, Blevins Middle School and Preston Middle School in Fort Collins, Colorado, Carlson Elementary School in Idaho Springs, Colorado and the Crossroads School from Baltimore, Maryland. Students from these schools and their chaperoning adults participated in programs in Desolation, Gray, and Lodore Canyon of the Green River, Ruby, Horsethief and Cataract Canyons of the Colorado River using the permits and professional guide services of Adventure Bound and Sheri Griffith Expeditions. Additionally, GOALS has made considerable efforts to improve the quality of the educational experiences we provide by improving the training we offer to GOALS program leaders and by refining the curricula upon which our programs are built for various age groups.
