

C - Funds for airfare and meals for speakers for a men's conference in Bogota, Columbia. The conference deals in issues specific to men from one community to another. Marriage, integrity, living skills, and addictions were addressed in this 3 day seminar. \$2,385 paid

D - Funds to transport volunteers, and to purchase materials to construct a combination church and community center in Surinam, South America. Volunteers from one community used their expertise in construction to advance the needs of another community in South America. \$33,737 paid

E - Funds designated to help with construction of a new Science and Math building on the CRISTA campus. \$500 paid

F - Funds to assist in travel and expenses of Mary Ballenger, DVM, to speak to the Oklahoma Veterinary Medical Convention on cross cultural veterinary medicine. \$500 paid

Page 2, Part III, Statement of Program Service Accomplishments

Primary Exempt Purpose: The corporation's purpose shall be (1) to promote community welfare on a local and international scale, (2) to enhance the development of economic and agricultural techniques, educational opportunities, community health and character development, (3) to work with individuals, non-profit agencies, foundations and churches to bring resources together for the enhancement and the development of communities, both locally and internationally, (4) through the practice of Christian principles, to care for and enhance the well being of others and, (5) to do all things and perform all acts permitted of a general corporation under the act.

Line 28 - Item A, from Schedule I, is part of a program associated with the Oasis Training Center which teaches English and computer skills to students in rural northwest China. The graduates find employment at better economic levels than would be possible otherwise. An estimated 80 students annually benefit directly and several hundred benefit indirectly through a community center and orphanage. **\$ 3,596**

Line 29 - Item B, from Schedule I, is a school facility operated by Savior's tear in Managua, Nicaragua. The school provides education and two meals daily for approximately 400 children who live near the Managua city dump. Students and parents are severely economically disadvantaged. **\$ 29,000**

Line 30 - Item C, from Schedule I, is a men's conference for men of Bogota, Columbia, sponsored by several local churches to teach and lead these local men to become better husbands, fathers and role models in their communities. **\$ 2,385**

Line 31 - Item D, from Schedule I, is a project in which funds were used to allow volunteers from the United States with building expertise to travel to Surinam and construct a church community center building. The construction materials were purchased locally using CEN donated funds. The building will be under the direction and supervision of the river village community in Surinam to meet their specific needs. One room in the building will be used as a refuge for community members in economic or social need. **\$ 33,737**

And Item E, from Schedule I, is a grant/donation to help in the construction of a Science and Math building on the CRISTA (a 501©3) campus for the educational purposes of King's Schools of Shoreline, Washington. **\$ 500**

And Item F, from Schedule I, is an honorarium for Mary Ballenger, DVM, to present to the Oklahoma Veterinary Medical Association a lecture on cross cultural veterinary medicine based on her position with Vet NET, a Mongolian NGO specializing in continuing education of Mongolian veterinarians. Vet NET also provides model herder programs in Mongolia which adds to the well-being of herders and ranchers in Mongolia. **\$ 500**
