

Medical Fundraiser Criteria:

To refer a candidate for consideration for a medical expense fundraiser, please read the below information to better understand our process.

Patient Qualifications:

1. Referrals must have currently or previously a life threatening medical condition.
2. Families must have financial debts of more than \$5,000 that they are responsible after insurance coverage if they are insured. Some candidates may not have medical insurance coverage at all.

Program Requirements

1. We raise the funds by reaching out to the patient's friends and family, mostly through email. Therefore the candidate must be willing to share email addresses (preferred) or postal addresses of their friends, family, church family, co-workers, etc. that might want to give monetarily to their fundraiser event
2. We operate our program through Volunteer coordinators/advocates. The fundraising candidate must have a friend who can be their advocate and take the lead as the fundraising coordinator. This coordinator would be the liaison between the fundraising recipient and Motivations Ministries. The coordinator would also be instrumental in preparing a celebration event where a check will be presented at the end of the fundraising term.

1. We furnish the website, email software to communicate, e-commerce and community outreach efforts
