Training: Human Impact Partners built the capacity of 15 organizations around the country, including government agencies and community organizations, to conduct Health Impact Assessments (HIA) by conducting 12 two-day trainings and providing 15 organizations with technical assistance as they conducted their own HIAs.

Awareness: Human Impact Partners raised awareness about the practice of Health Impact Assessment and the links between proposed policies, plans and projects and health by presenting at over 10 conferences and developing and disseminating case studies, fact sheets and other communications materials.
