Anna Julia Cooper Episcopal School now serves 68 students in 6th, 7th and 8th grades. The school day begins with prayer, breakfast and announcements. The morning classes consist of Math, Science, History and English. Hot lunch is served at midday and the afternoons consist of Physical Education, Art, Music, Improvisation, Religious Education and Spanish. Every Friday afternoon there is a chapel service. There is also an extended day program that offers homework assistance, tutoring, and sports. The summer program offers Math and English enrichment classes, basketball, art, cooking, games and music. Overnight camping trips at Camp Alkulana and Jacobs Ladder complete the summer program.
