sessions, the board of directors and legal counsel present our policies and procedures, which includes our fiduciary statement of
responsibility, conflict of interest policy, mandatory reporting, confidentiality statements, technology statement, fundraising policies and
procedures.

15b - All staff and consultants are required to conduct a background screening and drug screening (for programs involving children under 18
and federally funded programs). Following prior employment reference checks and interviews, applicants area are review by the executive
board committee and then the full board. On hire the executive director will orientate the candidate including the policy and procedures,
policy statements, holiday schedules, operating schedules, and program vision and objectives. The candidates progress is reviewed by the
board of directors at our quarterly meetings. Candidates are required to provide monthly and quarterly reports to the executive director who
subsequently reports to the whole board on a quarterly basis.
