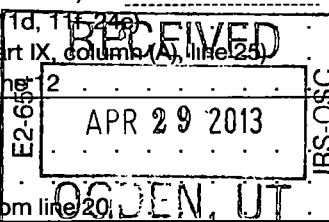

Dog Transfers to No Kill Shelters for Adoption

Due to gross over-crowding and animal over-population, FOTAS volunteers work aggressively to ship as many (primarily) dogs as possible to no-kill shelters out of state. FOTAS has equipped a trailer as a dog transport wagon and also coordinates with a local horse-mover as part of the dog transfer program.

Spay and Neuter Assistance Program

FOTAS recognizes that there will never be an adequate public animal shelter if something is not done to reduce the number of unwanted dogs and cats through a variety of spay/neuter assistance programs. Beginning this year (CY 2012), FOTAS launched a spay/neuter assistance program with the help of local Animal Control. In addition to no-cost/low-cost surgeries, rabies vaccines are also provided. Animals are picked up from owners right in their home communities and delivered back the next day.

New Shelter Building and Equipment

FOTAS has committed to fund the architectural and engineering plans for a new county animal shelter as well as a large portion of the interior furnishings. An extensive "Building Fund" fund-raising campaign has been launched and will continue until the new facility is constructed, furnished, and operating to serve the animals housed there.
