Projects and Trips: This is 1040i's sole program. In 2012, 1040i conducted a trip to Cote d'Ivoire which provided medical services to the local people, with five surgeons using a mobile surgery unit. 145 surgeries were performed, including orthopedic surgeries, cleft palate repairs, removal of tumors, OBGYN procedures, and cataract surgeries. Over 1,000 pair of eyeglasses were distributed in conjunction with eye testing. Additionally, a construction team renovated a local school, constructed 2 community centers, and built 60 school desks. There were 67 team members on this trip. Another smaller trip to Cote d'Ivoire involving 9 team members resulted in 2 schools being renovated, 80 school desks being built, and 300 people receiving wound care. Two trips to Morocco were made in 2012 with 21 team members, where 2 schools were renovated, 500 eyeglasses were distributed after exams, 12 surgeries were performed, and 150 water filters were distributed.
