GNE Developed a Research Project at the request of the Nepal Government to study the effects of Micronutrients on the Health of Women of Childbearing age and their offspring. Contracted with a Nepali Corporation to perform the study. Vitamins were donated by Vitamin Angels and shipped to Nepal. Procured necessary research equipment and supplies. Travelled to Nepal to oversee and volunteer as researchers. All expenses are paid by private donations. We have only one program.

Research project in Nepal to assess micronutrient deficiencies in women of child bearing age. This is a Nepal Research Council approved project, conducted by Health Resources Consultancy, a Nepali registered corporation. Vitamins were donated by Vitamin angels at a retail value of \$150,000. Necessary research equipment and supplies was procured in the US and shipped to Nepal. Members of GNE travelled to Nepal and donated time to teach and conduct the research. All income to GNE is from private donations, and we have only one program.
