Hug It Forward is a grassroots organization that facilitates education and awareness by empowering communities to build "bottle schools" Bottle schools are schools built using "eco-bricks" made from plastic bottles stuffed with inorganic trash Entire communities come together to make the dream of educational opportunity a reality, by building their own upcycled bottle school Hug It Forward also strives to raise awareness in developed countries about trash, consumption and the power of community This mission is equally important to us as facilitating the construction of bottle schools in developing countries Our goal is to share the bottle school technology so that communities all over the world can build their own bottle school

BOTTLE SCHOOL CONSTRUCTION In 2012, Hug It Forward facilitated the construction of a total of 7 bottle schools, 6 bottle schools in communities across Guatemala and one bottle school in El Salvador, at an average cost of under \$6,500 per classroom Bottle schools are schools built using "eco-brcks" plastic bottles stuffed with inorganic trash Entire communities come together to build a more sustainable educational infrastructure for their future Bottle school projects are community-led, and community members volunteer all unskilled labor needed for the construction Each head of household is required to volunteer a set number of days on the construction site, depending on the size of the community and the size of the project Through this process, community members learn construction skills that they can then apply on future projects inside and outside the community Before Hug It Forward issues any funding for materials, many community meetings take place, the community completes an application process, and the community has to collect all of the 6,500 plastic bottles required for their new bottle school, and stuff them with inorganic trash from their immediate environment Some rural communities don't have enough bottles or trash, in which case neighboring communities collaborate and contribute eco-bricks, building relationships and bringing villages closer together Teachers and village leaders are responsible for organizing the process of bottle collection and overseeing the volunteering of labor, enabling them to learn project management skills that will stand them in good stead for future community projects, as well as giving them the confidence to take on ambitious large-scale projects in the first place Usually, the local municipality pays for the two skilled masons needed to build the bottle school, and the Ministry of Education pays for all teachers, ensuring that these institutions also have ownership in the project Through their participation in bottle school projects, the municipality and Ministry of Education are also inspired to look towards more innovative solutions to issues facing the community in the future, as well as being made aware of the importance of environmental sustainability

BOTTLE SCHOOL WORKSHOPS Hug It Forward's goal is to share the bottle school technology, so that communities across Guatemala and all over the world can build their own bottle school, wherever there is a need Hug It Forward volunteers have compiled the Bottle School Manual, a step-by-step guide to every stage of a bottle school project, from organizing and empowering a community to every part of the construction process This Manual is available for free to anybody in any community or organization who would like to build a bottle school In this way, we are able to share with the world the benefits of the experience and expertise we have been fortunate to gain in facilitating successful bottle school projects over the past three years Alongside the Bottle School Manual, we facilitate workshops and training events where masons, teachers and community leaders can learn about all aspects of the bottle school construction process In this way, the bottle school methodology can spread organically, and community members can empower themselves to build bottle schools in a way that is more sustainable than if Hug It Forward were to try to directly build all the schools that are needed

ENVIRONMENTAL EDUCATION PROGRAM In conjunction with bottle school projects, Hug It Forward also facilitates an environmental education program for youth, working with all the communities that participate in a bottle school project Children provide the majority of the unskilled labor in collecting inorganic trash and creating "eco-bricks" Children build their school with their own hands, giving them real ownership and pride in the realization of the project Environmental education is an essential part of the bottle school process, ensuring that the project's impact will be sustainable and that communities remain free of trash long into the future Through the environmental education program, children learn to understand the difference between organic and inorganic trash, along with the major risks of plastic pollution in their environment and in the world The intention of this process is to leave a lasting impact of the bottle school, helping to create awareness of environmental sustainability for future generations to come in these communities and beyond Hug It Forward's vision is of communities free of piles of inorganic trash on the roadsides, across the countryside, and in waterways, and free of piles of trash being burned for cooking and heating Education around the impact of trash on the local environment is just the beginning These lessons and conversations open the door for discussions around other major environmental issues facing communities across Guatemala and the world, such as deforestation, mining, and pollution of air and waterways Hug It Forward believes in the power of the youth to change the world Environmental issues provide a pathway to expose youth to questions around social justice, as well as a means to unite young people across communities in their own backyards and in other countries
