Spiritual Growth Producing a 24-hour, spiritually-engaging, non-commercial radio format that fosters spiritual growth in the lives of individual listeners, leveraging both Christ-centered music and practical Bible teaching. The resulting spiritual growth in each individual is foundational to our purpose of advancing the gospel of Jesus Christ. There were over 2,700 written interactions with listeners, including prayer requests, daily Bible reading commitments, and life-changing impact stories. 19 compelling Bible teaching programs and short features brought spiritual perspective on marriage, parenting, finances and life challenges. Over 1200 listeners received our music advisory team survey each month, providing valuable feedback to keep our song list relevant to listener preferences. Online listening exceeded 360,000 hours and our informative website received approximately 1000 visits daily.

Connection Fostering cooperation among churches and faith-based ministries by serving as a common connection point for information. Relationships are built with leadership of churches and faith-based ministries and information is gathered about their activities and then communicated through our website, on-air announcements and produced spots. Approximately 175 Nebraska churches, ministries and individuals had the opportunity to share highlights of God's work through ministry spotlights, morning conversations and other on-air segments. Listeners connected with us about 4000 times regarding posting community events, on-air celebration announcements, and interactive contests. Nearly 4300 people received our monthly newsletter, keeping them connected to local ministry opportunities and events. About 4000 received regular social media updates.

Mobilization Maximizing evangelistic opportunities by mobilizing listeners to new levels of spiritual advancement across denominational lines. Carefully selected high-impact opportunities and events are heavily promoted in order to call the listener to action. In 2012 some of these action points included 330 listeners committing to daily Bible reading time, 84 attending a marriage enrichment conference, 30 families taking training classes to become foster parents, 75 listeners adopting a needy family at Christmas, and 1000 people downloading evangelistic flyers to give while paying for the car behind them in the drive-thru.
