

We hire veterinarians to provide free and low cost veterinary services to low income pet owners. This is the major part of our efforts at this time. In 2012 we treated 5,950 low income household pets, a 20% increase over the previous year. while at the same time we reduced the cost of each by 11%, making our program provide more services on lower cost. In 2012 we also made 41% more grants in free veterinary services and medicines than the previous year. We also held four totally free vaccination days and four totally free full veterinary service days for victims of Hurricane Sandy.

We also operate a 24/7 telephone hotline for pet owners to get answers to their questions/problems. We receive approximately 15,000 calls every year, and give advice and referrals to help solve pet owners' problems so that can keep their pets instead of surrendering them to municipal animal shelters for euthanasia.
