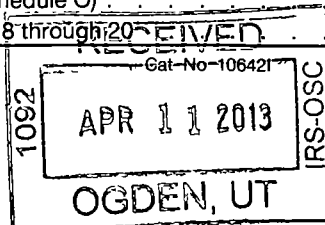

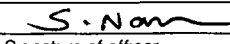

sales has been extremely slow. Over 100 books have been distributed free of cost to aspiring students. Grants to foreign charities made to
