

In addition to the community training, we trained Kenyan local fabrication teams in water filter and small business marketing practices. In Burundi we trained two teams of welders in biosand water filter mold construction, and supported local health and sanitation outreach & water filter fabrication teams. In Honduras and Zimbabwe we provided steel molds, construction materials and training in the use and fabrication of locally produced biosand water filters.

Part I Line 16: This represent costs associated with 1) our stateside training classes, 2) room rentals, 3) training materials, 4) Insurance, and 5) misc administrative costs, bank & wire transfer fees associated with the operation of our organization.

Part I Line 19: This is the 1st year we filed a 990ez form. for 2010,2011, we filed the 990-n as our total revenue was less than \$50,000.00. We do not have a previously filed 990ez return to reference.

We offered limited tuition scholarships for our stateside instructor training programs.
