In 2012, Project Vision Hawaii (PVH) was awarded an Innovations Grant from Pam and Pierre Omidyar to promote "innovative" approaches to Hawaii issues encountered in the non-profit sector. PVH through software (CDMP) to be developed will provide a clinical data repository to improve patient engagement, integration of care, advanced decision support and population reporting. CDMP can increase access and education through the web or smart phone. It will allow a screening participant to access eye screening results and recommendations, then share it with their primary care physician. It will assist a patient to ID providers, then educate them in a culturally appropriate manner. CDMP will elevate the screening event to a longitudinal experience. Currently people who receive screenings at events are only provided results and education onsite, with some follow up via telephone, snail mail and more rarely email. Our innovation will standardize follow up as an addendum to existent agency protocols using a software platform that allows the screening participant to access educational materials and results anytime as well as sends emails to the participant regarding follow up. This innovation will ideally serve as a gateway into the healthcare system in direct collaboration with community health centers and the native Hawaiian Health systems. Profiles will be Tailored/individualized and will capture patient's information at repeat screenings. In areas of high health disparity we will send reminders of our next screening events so we may again serve as an intimate resource to guide people back into the system.

PROJECT VISION HAWAII, Learning Disabilities Association of Hawai'i and the Lions Clubs International have formed a collaboration to provide vision, retinal, hearing and developmental screenings for the children of thirteen preschools on the Leeward Coast of O'ahu. The target population includes approximately 800 three- and four-year- old children attending these preschools. These events are open to families and engage other community health resource partners, increasing program sustainability and positively impacting the health and school readiness of children.

The Office of Hawaiian Affairs awarded a \$24.9K grant to enhance technology and health data management for the PROJECT VISION HAWAII mobile screening service directed to the Hawaiian communities. Working with community partners to conduct community events that promote "self-help" health education, the Hawaiian people can identify their own health concerns, what and where local health resources are available, and their own vision health via an online portal through an interactive web-based portal. Many Native Hawaiian participants were provided with the tools for self-promotion of health with increased access to screening results, education, and provider information. As an open source, HIPAA compliant software providers will have increased access to patient results, therefore, improving efficiency and provision of follow up care.
