At African Road, Inc we partner with local Rwandan leaders who help orphaned youth and widows in rural Rwanda for the purpose of poverty reduction In these vulnerable communities, we provide practical, hands-on assistance through financial aid, project planning, strategic thinking, and implementation of income generating businesses For instance, we have partnered with Pastor Steven Turikunkiko in Gasogi village to purchase and develop a small farm and goat business for orphaned youth and begin a tailoring business for widows

In 2012 African Road, Inc continued the fulfillment of its mission through many small projects The agricultural land purchased in 2011 for the orphaned youth of Togetherness Cooperative has grown and developed Several more parcels were purchased to expand the size of the farm and provide valuable road frontage Also, the orphans have begun many diverse income generating projects with small start-up investments a village preschool, cows and chickens, and better farming practices for plantains, a valuable cash crop Also, funds have been invested in improving the soccer field, a community gathering place and cultural center in their village, and boring a well on the land, a profoundly significant improvement to their lives We continue to provide basic support for the Turikunkiko family who care for 20 orphans Monthly funds go to paying rent, buying food, paying school fees, and meeting medical needs We are only able to provide the level of program support that we do because of our all-volunteer board and staff Many people have donated their time and skills to our work This year we implemented a matching funds campaign in order to raise the capital needed to purchase a home for the Turikunkiko family and the 20 orphans in their care This will provide a stable and safe place for the family to continue their work of transforming young lives Owning a home is a sustainable solution to sending money every month for rent A foundation granted two for one matching funds for all new donors, so we worked hard to enlarge our donor base and spread the story of African Road We raised \$30,000 from people donating to African Road for the first time, and with \$60,000 from the foundation, look forward to purchasing a home for the Turikunkiko's family in 2013 In April 2012, African Road received a grant designated for the purpose of producing a promotional film in order to increase fund-raising Filmmaker Parker Logan of ParkerLoganMedia traveled to Rwanda, filmed the work of African Road with Rwandan youth, and produced the piece as well as beautiful stills to use in all of our materials
