During the month of December, Baby DJ provided Christmas gifts, trees, and food to socioeconomically disadvantaged families in Central Florida so that they were able to experience the magic of Christmas. This season we were fortunate to provide grants to more than 4,400 children in our community.

Operation Princess Project took place in February and March. Through this program, we collect new and gently used formal wear and establish a temporary "boutique" from which socioeconomically disadvantaged high school students can then select clothing and shoes to be worn to attend their high school prom or other formal dance. The program allows students from economically disadvantaged families an equal opportunity to experience this memorable event. During the 2012 season we were able to provide formal wear to more than 700 local students.
