K9s4COPs Established our relationship and credibility with our Kennel of Choice Vohne Liche Kennels by participating in the following events and negotiating the training of our participants. K9s4COPs participated in the filming of Alpha Dogs for the National Geographic Channel, educating the public on the need and use of K9s in law enforcement. The participants were our grant awardees who were at the Kennel selecting their K9s. K9s4COPs was a sponsor at the Vohne Liche K9 Olympics, where we had the opportunity to meet, learn and work with K9 units from across the nation in government, school districts, cities, and counties. It provided an opportunity for our organization to establish it's credibility and commitment to law enforcement agencies.

Once approved, the Grant recipients travel to Vohne Liche Kennels in Peru, Indiana to select their K9s. K9s4COPs pays the kennel directly for the K9 and the agency signs and takes possession of the K9. All agencies are required to turn in yearly health reports and quarterly statistics to ensure the K9 is being cared for and is working in the community.
