ARTICLES OF INCORPORATION
OF
RUN FOR HOME HAVEN

The undersigned certify that:

1. They are the president and secretary, respectively, of RUN FOR HOME HAVEN, a California corporation.

2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

I. The name of this corporation is HUMANITY FOR HORSES.

II. A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

B. The specific purpose of this corporation is to establish and maintain humane alternatives for horses through rehabilitation and adoption, avoiding horse slaughterhouses.

III. A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the *Internal Revenue Code*.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

IV. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the *Internal Revenue Code*.
