Father Rick Frechette, an American priest and doctor, started the St Luke mission in collaboration with an inspired group of young Haitian leaders, who, together, saw a different path forward for their country. The goal of Fondation St. Luc is to create lasting solutions for a stronger and more independent Haiti.
