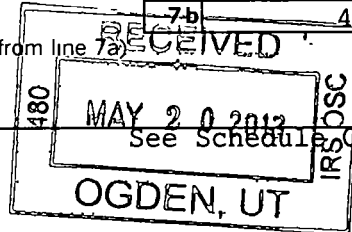



Run for Courage has been organized to generate awareness and support restoration of victims of sex trafficking and to carry on other charitable, religious or educational activities associated with this goal as allowed by law.

Form 990-EZ, Part III, Line 28 - Statement of Program Service Accomplishments

In the United States there are between 100,000- 300,000 children at risk of being sold for sex and trafficked each year. In 2010 Run For Courage became a non-profit to combat what we call "Modern Day Slavery". We do this in two ways. We raise awareness through education and prevention and we raise funds through our running races. Some of our accomplishments this year include: Educating over 2000 students 13-20 years old on Human Trafficking, which has included The National Trafficking Hotline, Red Flags of Trafficking, Explanation of manipulation and coercion, Definitions of and explanation of vulnerability, Human Trafficking terminology, Resources, etc.. We have hosting over 5000 participants at our running races. We have raised over \$300,000 to combat trafficking, and We have given funds to 6 different beneficiary restoration programs. In order to evaluate the restoration programs we choose, we employ our Evaluate-Donate-Monitor methodology. This methodology allows us to choose programs that most efficiently utilize their resources on services for victims. These programs have included counseling services, equine therapy, survivor curriculum, residential program services, and drop in care for victims. At Run For Courage in 2012 91.58% of our funds have gone directly to our mission.
