OUR ONGOING WORK INCLUDES REGULAR SPEAKING EVENTS AT COMMUNITY AND UNIVERSITIES. OUR GUEST TALKS AT THE UNIVERSITY OF HAWAII INCLUDED CLASSES IN POLITICAL SCIENCE, ETHNIC STUDIES, HAWAIIAN STUDIES AND WOMEN'S STUDIES.

HPJ ORGANIZED A SERIES OF EDUCATIONAL EVENTS INCLUDING PRESENTATIONS BY INTERNATIONALLY RECOGNIZED PEACE AND HUMAN RIGHTS LEADERS AND EXPERTS ABOUT THE CONDITIONS IN GAZA, VIOLENCE AGAINST WOMEN IN THE MILITARY AND THE LEGACY OF GOVERNMENT SPYING ON ACTIVIST GROUPS. A NUMBER OF OUR EDUCATIONAL EVENTS FOCUSED ON THE IMPACTS OF MILITARIZATION IN THE PACIFIC REGION AND PEOPLES MOVEMENTS TO COUNTER THESE IMPACTS. HPJ CO-SPONSORED THE WATADA LECTURE SERIES VISIT TO CRITICALLY EXAMINE THE MILITARY POLICY IN THE ASIA PACIFIC REGION, ORGANIZED A STUDENT GROUP AT THE UNIVERSITY OF HAWAII THAT BUILDS SOLIDARITY BETWEEN DIFFERENT ASIANS AND PACIFIC ISLANDERS ON CAMPUS TO DEVELOP A COMMON AGENDA FOR PEACE AND JUSTICE, CO-SPONSORED A COMMEMORATION EVENT FOR THE MARSHALLESE SURVIVORS OF THE BIKINI ATOLL NUCLEAR TEST, AND PARTICIPATED IN THE MOANA NUI II CONFERENCE IN BERKELEY, CALIFORNIA.

OUR EDUCATIONAL GEOPOLITICAL TOURS OF OAHU ARE BECOMING VERY POPULAR. IN 2013, WE CONDUCTED NINE TOURS FOR OVER 130 PEOPLE.
