


The grants made by ZMP in 2012 totalled \$68,288. The purposes of the grants are stated in Part III. Grants are generally made via wire transfers to the bank account of the local organization in Zimbabwe. ZMP has significant influence over how the funds are actually dispensed in Zimbabwe; however, ZMP does not have signing authority over the local Zimbabwean bank account. Thus the contributions are grants to the local organization, not direct payments to vendors, schools, workers etc.
