The following information is submitted in accordance with Treasury Regulation Section 1.6043-3a1 and the Form 990-PF instructions During the taxable year ending December 31, 2012, CGLC Charitable Trust the Foundation made distributions from assets from sources other than current income. Collectively, the distributions in excess of current income totaled 5,375,000. This amount represents over 25 of the Foundations net assets of 7,851,123 as measured by fair market value at the beginning of the Foundations taxable year ending December 31, 2012. Although the Foundation technically experienced a substantial contraction, it will continue in existence and has no plans for dissolution.
