Expanded the services of Rapha Academy Fresh Start Childcare Center, a Christian preschool and aftercare program for infants beginning at 6 weeks through children 14 years of age, to include Saturday hours. Weekday hours are 6:00 a.m. to midnight, and Saturday hours are 6:00 a.m. to 6:00 p.m. 81 children received services in 2012, an increase of 31% from 2011. Opportunities to learn about childcare services and administration were provided through three venues: 1 intern from the Lorain County Community College Financial Aid Work Study Program provided 640 hours of service; 6 interns from the TANEF Summer Work Program provided 1,680 hours of service; and an independent college student interested in shadowing to learn about administration and childcare licensing provided 256 hours of service. 5 volunteers served as evening receptionists for 16 weeks, totaling 320 hours. The Executive Director provided approximately 1,500 hours of service at no charge. As both a service to the community, and as a way of promoting services provided by the Center, facilities were provided at no charge to GED classes for two semesters (40 students served), ESOL classes for one semester (5 students served), and the Community Connect Computer Program for two sessions (24 students served).
