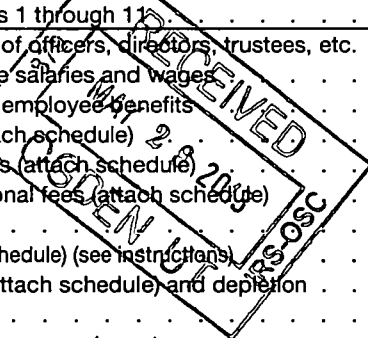

The Foundation has made scholarships to students in Taiwan. It has made scholarship grants through the following charitable organizations:

Cheng Chung & Chung Yeh-Jui and Education

Foundation

(scholarships made directly to approximately 20 students per year)

The procedures for granting scholarships in Taiwan are as follows: After receiving applications, the Foundation selects an initial list of approximately 100 to 120 students who are the most needy and eligible. The Foundation then sends volunteers to visit each student and their families. It selects approximately 18 students to receive a scholarship. The volunteers visit the families and the students to make sure that the students have a bona fide financial need, that the student has outstanding personal qualifications, character and academic achievement, and that the student has a very positive attitude toward school and learning.

Recipients are not selected or rejected on the basis of their race, color, religion or national origin.

No student may receive a scholarship if that person is related in any way to an organizer or employee of the Foundation, a disqualified person, or any person who is related to or friends of such persons or of volunteers who visit the students and their families.

The submission deadline is June 30 of each year. Scholarships are awarded by the end of August of each year.
