BYLAWS OF
FOUNDATION FOR COMMUNITY PARTNERSHIPS, INC.

Article I. PURPOSES

The corporation is organized and operated exclusively for such charitable and educational purposes as are within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 as set forth in the Articles of Incorporation.

Article II. BOARD OF DIRECTORS

Section 1. General Powers. There shall be a Board of Directors of the Corporation which shall supervise and control the business, property, assets and affairs of the Corporation, except as otherwise expressly provided by law, the Articles of Incorporation of the Corporation, or these bylaws.

Section 2. Number and Tenure of Directors. The Board of Directors shall consist of not less than seven and no more than twenty-one (21) members. Candidates shall be nominated by the Governance Committee and elected by the Board of Directors at a regular meeting.

Each director shall hold office for a term of three (3) years. Directors may not serve more than nine (9) consecutive years on the Board. Any person who serves nine years must be off the board for at least one (1) year.

Section 3. Officers of the Board of Directors. The officers of the Board of Directors shall be a Chair, Vice Chair, Treasurer, and Secretary. All officers shall be directors and shall be elected by the Board of Directors at the meeting prior to the beginning of the fiscal year or whenever a vacancy occurs. Each officer shall serve for one year or until a qualified successor is elected.

Section 4. Removal and Resignation. Any officer or director may be removed by affirmative vote of a majority of the current directors on the Board of Directors for failure to participate, non-performance of duties (i.e., missing three consecutive meetings) or other cause deemed sufficient by the Board. Any director may resign from the board at any time by giving written notice to the board Secretary. Such resignation shall take effect at the time specified in the notice, or if no time is specified, then immediately.

Section 5. Vacancies. Vacancies may be filled for an unexpired term by majority vote of the remaining members of the Board of Directors.

Section 6. Compensation. Directors shall receive no compensation for their services as such but may be allowed reimbursement for their expenses actually and reasonably incurred on behalf of the Corporation, within the limitations imposed upon nonprofit charitable organizations by Maryland and/or federal law. Nothing herein contained shall be construed to preclude any Director from serving the Corporation in any other capacity and receiving compensation within the constraints of Maryland law and federal law relating to nonprofit charitable organizations.

Section 7. Emeritus Members. The Board may elect past Foundation Board members to be Emeritus Board members. Emeritus Directors may be nominated and elected at any annual meeting of the corporation. Election of Emeritus Directors shall be by a majority of the members of the Board of Directors. Emeritus Directors may not continue in a previously held position as a member of the Board nor shall Emeritus Directors be considered as a member of the Board for purposes of limitation on the maximum allowable number of directors set forth above, nor shall death or resignation of an Emeritus Director be deemed to result in a vacancy on the Board of Directors. Emeritus Directors shall be elected to serve a lifetime term and shall have all the privileges of a director, such as committee membership and attendance at meetings, except that Emeritus Directors shall not have any voting rights.

Section 8. Self-Dealing Transactions. The Board shall not approve a self-dealing transaction except in accordance with this section and in compliance with Section 2-419(b) of the Maryland General Corporation Law. A self-dealing transaction is one to which the corporation is a party and in which one or more of the directors has a material financial interest or a transaction between this corporation and one or more of its directors or between this corporation and any person in which one or more of its directors has a material financial interest. The Board of Directors may approve a self-dealing transaction if the Board determines that the transaction is in the best interests of and is fair and reasonable to the corporation, and after reasonable investigation under the circumstances, determines that this corporation could not have obtained a more advantageous arrangement with reasonable effort under the circumstances. Such determinations must be made by the Board, in good faith, with knowledge of the material facts concerning the transaction and the directors' interest in the transaction, and by a vote of the majority of the directors then in office, without counting the vote of the interested director(s).

Article III – OFFICERS AND COMMITTEES

Section 1. Officers. The officers of the Board shall be elected by the Board of Directors and shall consist of the Board Chair, Vice Chair, Secretary and Treasurer.

Section 2. Powers and Duties of Officers.

- a. Chair. The Chair shall preside at all meetings of the Directors and shall give active direction and oversight pertaining to the corporation to the Executive Director.
- b. Vice Chair. The Vice Chair shall, in the absence of the Chair or in the event of the Chair's death, inability or refusal to act, perform the duties of the Chair. When so acting, the Vice-Chair shall have all the powers of and be subject to all the restrictions upon the Chair.

- c. Secretary. The Secretary shall keep minutes of all meetings of the Board of Directors and the Executive Committee; see that all notices are duly given in accordance with the provisions of these bylaws; ensure staff members keep corporate records; and in general perform all duties incident to the office of Secretary.
- d. Treasurer. The Treasurer shall oversee the keeping of the financial records of the Corporation; act as custodian of Corporation monies and ensure that they are deposited in a bank designated by the Board of Directors; oversee development and management of the annual operating budget; present financial statements to the Board; and in general perform all duties incident to the office of Treasurer.

Section 3. Board Committees

- a. Executive Committee. Between meetings of the Board of Directors, oversight of the affairs of the Corporation shall be conducted by the Executive Committee consisting of the officers of the Corporation.

The Executive Committee shall be authorized to perform duties as may be prescribed by the Board of Directors except those expressly reserved by resolution of the Board or by these bylaws. The Secretary shall give reasonable notice to each member of the Executive Committee of the time, date and place for each committee meeting. The Executive Committee may act by a majority of its members at a meeting; or informally without a meeting, provided a majority of its members consent in writing reflecting such informal action. A consent delivered by facsimile or electronic mail shall constitute a valid consent under this section. The Executive Committee shall keep written records of all of its actions and all actions of the Executive Committee shall be submitted at the next regularly held meeting of the Board.

- b. Governance Committee. The Governance Committee shall consist of at least three (3) Board members appointed by the Chair to perform duties related to the identification, nomination and development of board members; drafting and oversight of the Corporation's governing documents; and guidance on governance and policy matters of the board.
- c. Audit Committee. The Audit Committee shall consist of at least three (3) qualified Board members appointed by the Chair to oversee internal controls and the annual independent audit of the corporation. The committee meets quarterly and reports to the Board at regular Board meetings.
- d. Finance and Investment Committee. The Finance and Investment Committee shall consist of at least three (3) qualified Board members appointed by the Chair to ensure the Foundation's fiscal responsibility and stewardship by defining the Foundation's financial policies, monitoring its fiscal health and responsibly overseeing its investments.
- e. Other Committees. The Board of Directors may appoint such other committees as it deems necessary to implement the purposes of the Corporation. Such committees shall have the

power and duties designated by the Board of Directors, and shall give advice and make non-binding recommendations to the Board.

- f. Service by Non-Board Members. The Chair may appoint non-Board Members to serve on Board Committees. Committee members shall perform duties designated by the Board of Directors and shall give advice and make non-binding recommendations to the Board.

Article IV - MEETINGS

Section 1. Regular Meetings. A regular meeting of the Board of Directors shall be held quarterly for the purpose of transacting such business as may come before the board. All board members are expected to attend regular board meetings.

Section 2. Annual Meeting. The Board of Directors shall hold an Annual Meeting. The Board shall determine the time of the Annual Meeting by resolution. Notice of the time, date and place of the Annual Meeting shall be given in the manner set forth in Article IV, Section 4. All meetings shall be governed by Robert's Rules of Order. The Board of Directors shall keep minutes of its meetings and a full account of its transactions. In the absence of notice or call, the Annual Meeting of the Board shall be held in March.

Section 3. Special Meetings. Special meetings of the Board for any purpose or purposes may be called by or at the request of the Chair, or by any 10 directors, upon written notice to the Secretary and in accordance with Article IV, Section 4 herein. The purpose for which a special meeting is called shall be stated in the notice.

Section 4. Call and Notice. The time, day and place of any meeting of the Board of Directors shall be given at least 5 days prior to the meeting by written notice to each Director delivered personally, by first class or registered mail, by facsimile or by electronic mail. If notice be given by facsimile or electronic mail, such notice shall be deemed to be delivered when the proof of transmittal is received by the sender. If mailed, such notice shall be deemed to be delivered when deposited in the U. S. mail with postage prepaid thereon, to the Director's last known address according to the Corporation's records.

Any director may waive notice of any meeting. The waiver must be in writing, signed by the director entitled to the notice, and filed with the minutes of the corporate records. A director's attendance at or participation in a meeting waives any required notice of the meeting.

Section 5. Quorum and Voting. At every meeting of the board, a quorum shall consist of one half (1/2) of the current directors serving on the Board of Directors. Unless otherwise specified in these bylaws, the majority vote of those persons actually present at a meeting at which there is a quorum will prevail on all matters. Members of the Board of Directors may give their proxy only for the purposes of ensuring a quorum. Proxies should be provided in writing through the mail or via electronic mail.

Section 6. Participation in Meetings by Conference Telephone. Members of the Board may participate in a meeting through use of conference telephone or similar communications equipment, so long as all members participating in such meeting are in simultaneous communication with one another; all such Directors shall be deemed to be present in person at such meeting.

Section 7. Action Without Meeting. Any action required or permitted to be taken by the Board may be taken without a meeting if 2/3 of the members of the Board consent to such action in writing or by electronic mail, or if consent is granted through an action of the board at a previously scheduled board meeting. Such consent or consents shall be filed with the minutes of the proceedings of the Board.

Article V – FINANCIAL AFFAIRS

Section 1. Fiscal Year. The fiscal year of the Corporation shall begin on January 1 and end on December 31 of each year.

Section 2. Bank Accounts. The funds of the Corporation shall be deposited in one or more banks or financial institutions as designated by the Board of Directors.

Section 3. Insurance. The Corporation shall secure insurance to protect the Corporation, the Board of Directors, the officers, and the employees from liability.

Section 4. Indemnification. To the maximum extent permitted by the Maryland General Corporation Law, as from time to time amended, the Corporation shall indemnify its currently acting and its former directors and any director who serves or has served, at the request of the Corporation, as a director, officer, partner, trustee, employee or agent of another corporation, partnership, joint venture, trust or other enterprise against any and all liabilities and expenses incurred in connection with their services in such capacities. The Corporation shall indemnify its currently acting and its former officers to the same extent that it indemnifies its currently acting and its former directors, and may indemnify its currently acting and its former officers to such further extent as is consistent with law. The corporation may indemnify its employees and agents and to the extent determined by The Board of Directors. The Corporation may also advance expenses, to the extent permitted by the Maryland General Corporation Law, to persons referred to above.

Article VI - MISCELLANEOUS

Section 1. Geographical Region The Board recognizes that the Foundation for Community Partnerships, Inc. is a community foundation that serves the Chesapeake Bay Region.

Section 2. Amendments. These bylaws may be amended by a majority of Directors in office at the time the amendment is adopted. The Corporation shall provide notice of any meeting of Directors at which an amendment is to be approved. The notice shall be in accordance with Article IV,

Section 4 hereof. The notice must state that the purpose, or one of the purposes of the meeting is to consider a proposed amendment of the bylaws, and contain or be accompanied by a copy or summary of the amendment.

These bylaws were accepted and adopted by the Board of Directors as the bylaws of the Corporation on the 10th day of August 2004 and amended and subsequently approved by the Board on June 9, 2008, December 16, 2009, December 14, 2011, and December 12, 2012.
