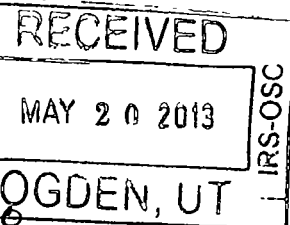

Ameinu – Our People, Inc. was incorporated on March 29, 2010. It filed for tax exempt status under 501(c)3 in February 2012.

It took a year for an IRS exempt specialist was attached to its application. During that time Ameinu – Our People did not operate, did not raise funds, nor do any programming. It did not want to do anything until obtaining approval for its tax exempt status.
