### ELIGIBILITY

Grants are made to entities recognized as tax-exempt charities under 501 (C) (3) of the Internal Revenue Code

Grants are awarded semi-annually. An eleven member volunteer Distribution Committee, supported by our professional staff, reviews and discusses each proposal submitted

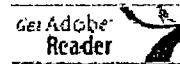
